Sub: Grant of conditional permission to the Faculty of Ayurvedic Science, Jayoti Vidyapeeth Women's University, Vedant Gyan Valley, Jharna, Mahala Johner Link Road, Jaipur-Ajmer Express Way, NH-8, Jaipur-303122, Rajasthan with 60 seats in UG (BAMS) course under Section 13A of the IMCC ACT, 1970 for the academic session 2016-17. – reg.

Sir,

I am directed to refer to this Ministry's order No. R-12011/12/2014-EP (IM-1) dated 15.07.2015 related to permission of the Central Government to establish a new Ayurveda Medical College from the academic session 2015-16 intimating to develop the requisite infrastructure for 2nd professional for consideration of the case from the 2016-17 session.

- 2. The CCIM had carried out an inspection of the institution on 15.02.2016 to reassess the available facilities of teaching and practical training as well as to verify the compliance submitted by the college and forwarded its recommendations and report to the Ministry.
- 3. The recommendations and visitation report of the CCIM have been carefully examined in terms of the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations of 2013, provisions under the IMCC Act, 1970, relevant regulations made thereunder and as per approval of the Hon'ble MoS (IC), Ministry of AYUSH for the UG/PG course(s) for grant of conditional permission for the academic session 2016-17 vide Ministry's letter No.R.11011/01/2016-EP (IM-1) dated 12.08.2016 (available at Ministry's website <indianmedicine.nic.in>) and it is found that the College is fulfilling the notified and approved criteria as follows:-
- (i) <u>Teachers:</u> 100% eligible teachers, 06 Higher Faculty (Professor/Reader) in 06 departments, at least 01 teacher in each of 6 departments for upto 2nd Professional course and 09 Part time teachers;
- (ii) Beds in hospital: Minimum 60 beds in hospital of College for upto 60 UG seats;
- (iii) Minimum 120 patients per day in OPD during the year 2015 for upto 60 UG seats;
- (iv) Minimum 40% bed occupancy for UG College in IPD during the year 2015; and
- (v) Equipment and instruments: Minimum 90% of required equipment/instruments as specified under the schedule VII of MSR.

- (vi) Other infrastructure and requirements: as specified in sub-regulation (3) of Regulation 10 of the MSR Regulations of 2012 read with amendment Regulations of 2013, in addition to above requirements for grant of conditional permission.
- It has, therefore, been decided by the Central Government to grant conditional permission to the Faculty of Ayurvedic Science, Jayoti Vidyapeeth Women's University, Vedant Gyan Valley, Jharna, Mahala Jobner Link Road, Jaipur-Ajmer Express Way, NH-8, Jaipur-303122, Rajasthan to take admissions with 60 seats in (UG) BAMS course for the academic session 2016-17 under section 13A of the IMCC Act, 1970 subject to the condition that the college shall fulfil the following requirements by 31st December, 2016 which will be verified for granting permission for the academic session 2017-18 (a copy of Assessment Sheet of CCIM is also enclosed):
 - (i) Relevant provisions of the Minimum Standards Requirements of infrastructure and teaching & training facilities as specified in Regulation 3 and Regulation 10 of the "Indian Medicine Central Council (Minimum Standard Requirements of Ayurveda Colleges and attached Hospitals) Regulations, 2012 read with amendment Regulations of 2013 to get conditional permission for the session 2017-18;
 - (ii) relevant requirements under the (Minimum Standards of Education in Indian Medicine) (Amendment) Regulations, 2012 read with amendment Regulations of 2013 (for UG Ayurveda); and
 - (iii) the college shall obtain the NABH accreditation for the Hospital within one year and the NAAC accreditation for the College within two years from the issuance of the permission letter and the college shall submit its compliance to this Ministry as well as the CCIM within specified period.
- The fulfillment of the conditions attached to the permission given above may be made within the time period specified and compliance report should be submitted to the Ministry of AYUSH endorsing a copy to the CCIM also. The CCIM will verify by means of an inspection that the conditions have been fulfilled and submit a report in this matter to the Ministry of AYUSH for considering the permission matter for the session 2017-18.
- This issues with the approval of competent authority.
